COVID-19 Daily Brief – 25th March

➤ Site Position

- ▶ The Health Secretary last night confirmed that key workers should go to work. Government has identified Sellafield as a key site where work should continue in the national interest.
 - ▶ Sellafield took the decision last week to pause work and yesterday extended the pause for the rest of the week, to allow for the identification of the key work that needs to continue and which of the key workers are needed on site.
 - ▶ We are all focused on ensuring that the guidance regarding social distancing can be followed and will continue the ongoing discussions with your Trade Union representatives.

➤ Site Status

- The site is looking into a key worker staging process. The stages are listed below, from where we are now at stage 1 to full site operations in stage 6. As the stages are introduced all employees will be informed and letters will be issued.

Key Worker definition stages	Description	Site Status
Stage 6	Return to full operations	Green
Stage 5	All other project activity in support of progressing demonstrable progress	Orange
Stage 4	High hazard project delivery support strategic priorities and associated functional support (for example BEPPS/DIF, SRP, DDP)	Orange
Stage 3	Key hazard reduction activities (for example MSSS commissioning, special nuclear material activities and FGMSP retrievals) including key functional support	Orange
Stage 2	Medium term legislative compliance activities and functional support to the business (for example delivery of PMS, legionella testing, NSBS payroll). Key non shift based facilities that support longer term nuclear safety (for example WAMAC)	Red
Stage 1	Maintain safety and security of the site (for example shift operations, analysis, maintenance, site security and guard force) May also include critical leadership teams, planning support, engineering and maintenance.	Red
